

ANIMALS AND ABUSE

Animals are frequent targets in domestic violence relationships because they often represent an extension of the person who is being abused. Pets are used to demonstrate power and control over the family as well as means of maintaining control. Animals are threatened, beaten, or killed in an effort to maintain control over the person who is being hurt. Animal abuse is a recognized form of domestic violence because of the deep implications it has for a survivor. Threatening, injuring or killing animals indicates the potential for increased lethality in the relationship.

Domestic violence survivors and advocates have long recognized the abuse of pets; however, due to funding constraints and safety issues, shelters have been largely unable to provide shelter for animals. This inability has created a tremendous barrier to survivors as they contemplate leaving the relationship. Without a guarantee of pet safety, survivors are highly reluctant to leave.



Gucci was Jennifer's beloved pet at the time of her death.


